### **GUIDANCE NOTE FOR NOMINATION**

#### **About the Award**

1. Established in 2018, the Award is named in honour of Mr Joseph Grimberg (1933–2017), a highly-regarded former Judicial Commissioner and Senior Counsel in Singapore. He was viewed as one of Singapore's finest and most respected legal experts with exceptional leadership in the legal profession. This Award seeks to honour his memory by awarding an annual prize to a young lawyer (below 10 years PQE) who has shown excellence in his/her work and achievements, and who has also displayed outstanding professional excellence and ethical standards.

#### **Eligibility and Award Criteria**

#### 2. A nominee must:

- (a) be engaged in the practice of law for 10 years or fewer with a principal focus on advocacy;
- (b) be a well-rounded person actively involved in and committed to his or her community;
- (c) be 40 years of age or below at the time of application; and
- (d) be a member in good standing of the Singapore Academy of Law.

#### The Nomination Process

- 3. The administrative support is provided by the Singapore Academy of Law ("SAL"), which treats each application as confidential to the Selection Committee. We welcome nominations from law firms in Singapore, the Singapore Legal Service and individual applicants (self-nominations).
- 4. A Committee of the Singapore Academy of Law comprising Supreme Court Judge(s) will select the Award recipient. The Committee may call for interviews of shortlisted nominees.
- 5. Submission period: 1 April 2025 to 31 July 2025.
- 6. Please note that the nomination must be accompanied by two letters of recommendation. Examples include letters from the nominee's clients, individuals familiar with the nominee's service to the community, the nominee's current or former employers, fellow practitioners, individuals familiar with the nominee's service to the Bar, or any other individual who can explain why the nominee should be awarded the Award.
- 7. The completed nomination form, along with two letters of recommendation, must be received by SAL at awards@sal.org.sg no later than 4.30 PM SGT on 31 July 2025.
- 8. The Selection Committee reserves the right to reject nominations that are incomplete or do not comply with the instructions. To allow time for any necessary clarifications, applicants are strongly encouraged to submit their nominations at least 3 weeks before the closing date.

#### Notification of result

9. The Award will comprise a premium writing instrument and a trophy both sponsored by Drew & Napier LLC, with which Mr Grimberg had a long association. The winner will be notified in September 2025 and will receive the award from the President of SAL, The Honourable the Chief Justice Sundaresh Menon, at the annual SAL Appreciation and Awards Dinner on 15 October 2025.
